**TDU charges will be passed through to customer as billed from the TDU.

Your average price per kWh each month is determined by using the energy charges above and the following formula:

Price per kWh = (Base Charge + (monthly billed On-Peak Hours kWh usage x On-Peak Energy Charge) + (monthly billed Off-Peak Hours kWh usage x Off-Peak Energy Charge) + (TDU charges))/monthly billed kWh usage.

The total kilowatt-hour usage shown on your monthly invoice ("Billed Usage") is provided by the TDU. Usage for each time-of-use billing period shown above (On-Peak Hours or Off-Peak Hours) is determined from interval data from your advanced meter ("Interval Data") and is also provided by the TDU. If the Billed Usage and Interval Data do not match; any missing intervals in the Interval Data will first be determined using market information for your usage profile, then these intervals will be proportionately adjusted so the sum of all intervals equals the Billed Usage provide by the TDU.

This average price disclosure is an example based on average service prices and does not include applicable federal, state, and local taxes or any fees (including gross receipt tax reimbursement) or other non-recurring amounts charged by Constellation or a governmental entity. Your actual price for electricity may vary according to your exact monthly usage and TDU pass-through charges. Some locations may be subject to a TDU Underground Facilities and Cost Recovery Charge authorized by their city that is not included in this average price disclosure.
