The total kilowatt-hour usage shown on your monthly invoice ("Billed Usage") is provided by the TDU. Usage for each time-of-use billing period shown above (On-Peak Hours or Off-Peak Hours) is determined from interval data from your advanced meter ("Interval Data") and is also provided by the TDU. If the Billed Usage and Interval Data do not match; any missing intervals in the Interval Data will first be determined using market information for your usage profile, then these intervals will be proportionately adjusted so
